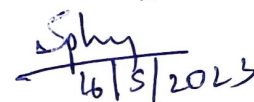
**Subject: Law and order crisis aftermath the Tribal Solidarity March (03-05-2023)-
seeking report on the destruction caused to Protected/Reserved Forest-reg.**

In continuation of this office letter of even no. dt. 13.05.2023 on the above subject, I am to submit that 291 (Two hundred ninety-one) encroachers have been evicted/removed from different Reserved Forests and Protected Forests of Manipur from 2017 to 2023 after following due process of eviction as provided under the Indian Forest Act, 1927 and Manipur Forest Rules, 1971 (Repealed in 2021). Details of encroachers evicted are enclosed as **Annexure-A/1** and **Annexure-A/2** for information and necessary action.
